

# SMOKING CABIN

## DOUBLE PLAZA HEPA PA

The smoking cabin Double Plaza PA is ideal if you want the smokers and non-smokers to stay in visible contact with each other. The combination of intensive air cleaning and the odourless storage of ash and cigarette ends ensures that the surrounding area remains free from annoying smoke and smells. The smoking cabins are flexible in size and equipped to fit any interior. For situations in which smoking is only allowed in restricted areas, the smoking cabin can be mounted with sliding doors, optionally with a self-closing mechanism. This smoking cabin Double Plaza PA (Public Area) is suitable for a frequently visited public area. Each filter cabinet has a double ashtray (large) with matching ash container, its adjusted start/stop system, and its gas oxidation filter.

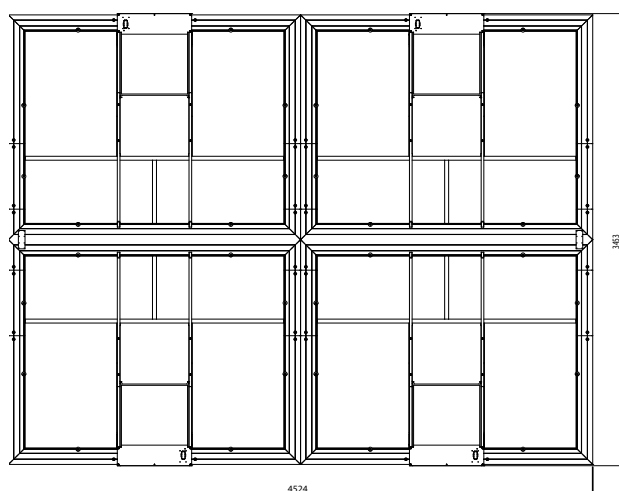

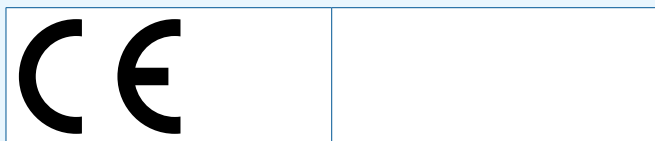
